Pre-registered players sign-in by 9 A.M. Same day registration MUST REGISTER between 8:15 to 8:45 A.M.

Championship section: G/30 Top five players will receive trophies.

Championship & Junior Varsity Sections: Will be USCF rated. USCF membership is required. New or expired members, add \$19 annual dues to entry fee submission. Unrated players may enter any section based on grade.

Junior Varsity & Novice Sections: Players will be divided into groups according to rating, experience & age. Games will be played continuously from 9:30 A.M. Two top players from each section will receive trophies; others will receive participation awards.

Registration: Early by mail \$35 postmarked no later than May 9th (firm) \$45 after May 10th and on site May 16th from 8:15 to 8:45 A.M. Tear-off must be accompanied by registration fee, no exception.

For Players With A Rating Over 1000 The Fee Is \$25!
